

Bengaluru City Police registered the case on September 9 after Gulshan Yadav, assistant vice-president of Gameskraft, approached the Marathahalli police and filed a complaint.

According to the FIR, on March 5 this year, Prabhu addressed the company in an email where he admitted that he had misused company funds for personal equity and derivatives trading over the past 3-4 years.

"He further stated that the total loss from such Equity F&O Trading as per his estimate exceeded Rs 250 crore. A reading of the said email also makes it clear that these activities were carried out without any disclo-

sure or approval," the FIR states. Police said Prabhu has not reported to work since March 1 and

is untraceable after sending the email.

"The accused stated that he would take full responsibility for his conduct, including for breaching the trust reposed to him in his capacity as Group Chief Financial Officer of the complainant company and claimed that none of the current or former employees of the complainant firm were aware of his conduct," the FIR adds.

# Masood Azhar's kin 'torn into pieces' in May 7 Indian strikes: JeM commander

A JAISH-E-MOHAMMAD (JeM) commander has admitted that the family of the terror group's ror attack, following which chief Masood Azhar was "torn Indian Armed Forces carried out into pieces" in the May 7 Indian missile strikes on the outfit's headquarters in Bahawalpur,

In a viral video uploaded to a YouTube channel on Tuesday, JeM commander Ilyas Kashmiri can be heard fuming over the Indian attack that killed the family members of Azhar and also bragging about fighting in neighbouring countries for Pakistan.

Kashmiri is reportedly speaking in Urdu at the Mission Mustafa Conference in Pakistan's Punjab province on September 6.

Standing among several gunwielding men, he said: "To protect the ideological and geographical boundaries of this country, we hit (wage a jihad in) Delhi, Kabul and Kandhar. And after sacrificing everything, on May 7, Maulana Masood Azhar's family members in Bahawalpur were torn into pieces (in Indian strikes)."

missile strikes on the terror targets, including Bahawalpur, a stronghold of the JeM terror group, on May 7 as part of Operation Sindoor. A statement attributed to Azhar had said that India's attack on Jamia Masjid Subhan Allah in Bahawalpur, some 400-km from

Lahore, resulted in the death of 10 of his family members and four close associates. Those killed included Azhar's elder sister and her husband, a nephew and his wife, another niece, and five children from his

extended family. The statement mentioned that the attack also claimed the lives of one of Azhar's close associates and his mother, along with two other close companions.

The Pakistan Army generals, senior police officers, and top bureaucrats had attended the funerals of those killed in Indian

Minor sexually abused by 15 people he met on dating app in Kerala, say police

A 16-YEAR-OLD boy in Kerala's Kasaragod district was sexually abused by at least 15 people he met on a dating app, police said. Nine persons have been ar-

rested in the case, including an Assistant Educational Officer and a Railway Protection Force member. Some accused are absconding, police said, adding that they include a local politician. Kasaragod

Superintendent of Police Vijay Bharath Reddy confirmed that the minor boy met the accused persons on a dating app. "He had met people who

were above 18 years of age. A person who joins the app has to give a self-declaration that he is above the age of 18. The boy has his own mobile phone with an internet connection and downloaded the app. There seems to be no parental control in his mobile use. He made the self-declaration that he is above the age of 18, and he has been exploited for the last two years," said the SP.

The officer also said police have so far registered 14 cases, of which six have been transferred to other districts — Kannur and Kozhikode – for investigation. The eight other cases, which are being probed in Kasaragod, have a total of 10 accused persons. According to police, the mat-

ter came to light after the boy's mother noticed behavioural changes in him. She informed the state's child protection helpline, after which he was given psychological counselling.
