Ancient shrine built 1,300 years ago

Thirukotteswarar Temple is located approximately 19 kilometres from Kumbakonam. It is the 137th of the 275 Paadal Petra Shiva Sthalams. situated on the banks of the river Kaveri. The presiding deity here is Lord Sri Koteeswarar, also known as Vedhanariswarar. The goddess is called Thirupurasundari, also referred to as Vedivambikai. The temple's sacred tree (Sthala Vriksham) is the Perambu plant. The Lord is also venerated as Sri Vedhravaneswarar.

The name of this temple is one of the few that ends with "Ka," which means "beautiful garden" in Tamil. The temple has been praised in hymns by the Saivite saints Appar, Sambandar, and Bhaskaraya. Lord Shiva here is a Swayambumurthi(selfmanifested).

History According to inscriptions,

this ancient temple was built about 1,300 years ago. The earliest inscriptions date back to 750 AD, during the reign of the Pallava king Nandivarman. It has seen contributions from the early and later Pallavas, the Pandya king Maran Sadayan, and the Chola kings Rajaraja I, Kulothunga I, and Kulothunga III. The current structure was constructed by Sembiyan Mahadevi, the mother of Uttama Chola, in 979 AD.

The sanctum sanctorum is composed of the sanctum, antarala (vestibule), and artha mandapam (hall). The artha mandapam is designed

above the sanctum follows the Dravidian architectural style. The outer floor has been elevated, concealing the adhisthana (base). The upana (plinth) is adorned with intricate sculptures, including dancing ladies in the Kuda Koothu style, as well as scenes from the Ramayana and the Siva Purana.

Legend

According to legend, it is believed that all 30 crore devas, sages, and angels of Hindu mythology ("Muppaththu Mukkodi Devarkal" in Tamil) have visited this temple and worshipped the Lord. The angels are said to have attained salvation ("Sayujya Mukthi") here.

While granting his darshan to the devas, Lord Thirukoteeswarar emphasized the sacredness of "Vedhravana Kshetram" (another name for Thirukkodikaval) and its holy waters. The Lord further said, "This, my kshetram here, is also known as 'Bhaavagam.' It is situated on the banks of the Kaveri, and it is very sacred. This kshetram is equal to my body. This tank, Sirungothbava Theertham, was created by Nandhi using his horns.'

The Lord also explained that when Mount Kailash and Thirukkodikkaval were placed on a balance, the latter weighed more, thereby proving its greatness.

Another legend tells of the Azhwars (Vaishnava devotees) who were instructed by Lord Venkatachalapathi of Tirupati to worship Goddess Thripurasundari here before offering worship at Tirupati. However, they could not reach this place as the river Kaveri was in flood at the time. goddess is believed to have granted her darshan in the form of the Lord.

It is also said that Lord Yama, the god of death, worshipped Lord Shiva here. Lord Shiva is believed to have instructed Lord Yama that no devotee who visits Thirukkodikkaval and worships him should be punished by Yama. Similar to Banaras, the people of Thirukkodikkaval do not fear the god of death. It is also believed that 1,008 devas surround Lord Shiva here, which is why there is no cremation ground ("Rudra Bhoomi") in this village. Instead, the villagers use the cremation ground on the other side of the riverbank.

Another legend involves Saint Haradhathar, who was born into a Vaishnava family in Kanchanur, a nearby village. He later became a devout worshipper of Lord Shiva. Every day, he would visit seven Shiva temples (Thiruvalankadu, Thiruvavaduthurai, Aduthurai, Thirumangalakkudi, Thirumanthurai, Thirukkodikkaval, and Kanchanur) before having his dinner. One day, after leaving this temple, a heavy rainstorm struck, and in the darkness, he could not find his way back to his village.

It is said that Lord Shiva, disguised as a villager, guided him back

The next day, when he visited this temple, he was surprised to see the food he had offered to the villager placed in front of the Lord. Haradhathar realized that the villager was none other than Lord Shiva himself.

According to the Sthalapuranam (temple legend), sages Dhurvasa and Agastya visited this place and performed penance. It is also believed that Rama, Balarama, Veerabhadra, and Kali worshipped the Lord here to seek absolution for their sins. Additionally, Saint Karaikkal Ammaiyar is said to have worshipped the Lord here. Legend has it that Karaikkal Ammaiyar came to this temple by walking on her head.

Deities

In addition to the shrines of Lord Shiva and Goddess Parvathy, the temple features shrines and idols of Karaiyetrum Vinayakar, Murugan. Nataraja, Gajalakshmi, Kalabairavar, Suryan, Chandran, Nalvar, Sage Agasthiyar, Sage Dhurvasar, and Chandikeswarar in its corridors. Interestingly, there is no Navagraham shrine

The corridors also house Shivalingams named after the four Vedas-Rig, Yajur, Sama, and Atharvana—as well as three Shivalingams worshiped by the mukkodi Devas. Lord Saneeswarar and Lord

Chitragupta, Yama's divine accountant, is placed opposite Sage Dhurvasar.

There is also a remarkable carving, made from a single stone, that depicts Saneeswarar's wife Jeastadevi along with their son Manthi and daughter Mantha. Surrounding the sanctum sanctorum. or "koshtam." are idols of Narthana Vinavakar, Natarajar, Karaikkal Ammaiyar, Dakshinamurthy, Lingothbavar Brahma, Astapuja Durgai, Pitchadanar, and Agasthiyar. Lord Brahma's idol is found in two places—once in the koshtam and again in a smaller shrine. The stone idol of Lord Nataraja, accompanied by Goddess Sivakami. is an exquisite sight. In addition to daily rituals, special pujas are performed on Chitirai Pournami, with a unique rice offering made to Chitragupta on this occasion. Sthala Viruksham

The sacred tree of this temple is the Perambu plant, known in Sanskrit as 'Vedhra Viruksham.' For this reason, the deity is revered as "Sri Vedhravaneswarar," with "vanam meaning forest and 'eswarar" meaning lord in Tamil. The temple's holy waters, or theerthams, include the Sirungothbava Theertham, the Cauvery River, and the Mukkodi Theertham.
