In the financial year 2022-23, passengers received a subsidy of Rs57,000 crore, which increased to approximately Rs60,000 crore in 2023-24 (provisional figures). He emphasised that the goal is to provide safe and improved services at minimal fares.

Highlighting the benefits of Railway electrification, the Minister noted that despite an increase in the number of passengers and cargo, energy expenses have remained stable. Indian Railways aims to achieve Scope 1 net zero emissions by 2025 and Scope 2 net zero emissions by 2030. This non-fossil energy-based goal will completely offset the Railway's carbon emissions.

The Railway Minister also announced that locomotives manufactured at the Madhepura factory in Bihar will soon be exported. Indian

Bangladesh and Sri Lanka, while locomotives are being exported to Mozambique, Senegal, Sri Lanka, Myanmar and Bangladesh. Additionally, bogie underframes are being exported to the United Kingdom, Saudi Arabia, France and Australia, while propulsion parts are being sent to France, Mexico, Germany, Spain, Romania
