

## "WE ARE IGNORING GOVERNOR'S INDEPENDENCE TEA PARTY OVER HIS ANTI-GOVT STAND": TAMIL NADU CONGRESS CHIEF

CHENNAI (TAMIL NADU) [INDIA] : Tamil Nadu Congress President K Selvaperunthagai said in a statement on Tuesday that they would boycott the tea party to be hosted by Governor RN Ravi on Independence Day at Raj Bhavan.

"The Governor has invited (us) to a tea party on Independence Day. Thanks for his invitation. The activities of the governors (are) becoming politically based during Prime Minister Narendra Modi's regime, which was not in the last 70 years," Selvaperunthagai said.

Slamming the governor, RN Ravi, Selvaperunthagai said, "The activities of the Governor of Tamil Nadu, RN Ravi, have been against the interests of Tamil Nadu and the government elected by the people since the day he took office as the Governor of Tamil Nadu."

He added, "The appointment of vice-chancellors at universities in the state has been delayed... Also, it is unconstitutional for the Governor to continue in office even after his tenure. Therefore, on behalf of the Tamil Nadu Congress, we are ignoring the tea party (to be) given by the Governor."

In February 2024, Tamil Nadu Chief Minister MK Stalin accused Governor RN Ravi of using the Assembly for his political activities.

"Protocol demands that the Governor address the House at the beginning of the session. The Governor, however, behaved in a way that made us believe that he was using the Assembly as an extension of his political activities. Was it not an act that denigrated a century-old Assembly? Was it not an act that slighted the people of Tamil Nadu? Was it not amounting to violating and denigrating the Constitution by which he took the oath of office?" CM Stalin had said.

## CM Kejriwal's direction for Atishi to hoist national flag invalid: GAD

NEW DELHI : Amid uncertainty over who will hoist the national flag during the official Delhi government function on Independence Day, the General Administration Department (GAD) here said Tuesday Chief Minister Arvind Kejriwal, who is in jail in a corruption case, cannot authorise minister Atishi to do so on his behalf.

GAD Minister Gopal Rai Monday directed the department to make arrangements for Atishi to unfurl the flag as the chief minister "desires". Responding to the minister's communication, GAD additional chief secretary Navin Kumar Chaudhary said the CM's direction is "legally invalid and cannot be acted upon". The GAD



officer has also said the chief minister's communication to Lt Governor V K Saxena on August 6 in this regard was "not permissible" according to the prison rules.

Chaudhary said preparations for the Independence Day

directed is awaited, Chaudhary said.

Rai had issued his directions to the GAD on Monday after a meeting with Kejriwal in the jail. In a letter to the LG last week, Kejriwal said cabinet minister Atishi would hoist the national flag in his place during the Delhi government's Independence Day programme. The LG office, however, maintained that they did not receive any communication from the chief minister. Also, the Tihar Jail authorities informed Kejriwal that his letter to Saxena was "an abuse of privileges" granted to him under the Delhi Prison Rules and, therefore, it was not sent to the addressee.

## SC extends interim bail to businessman in Delhi Excise policy scam case



NEW DELHI : The Supreme Court on Tuesday extended the interim bail granted to Hyderabad-based businessman Abhishek Boipally in a money laundering case related to the alleged Delhi excise policy scam. A bench of justices M M Sundresh and Aravind Kumar adjourned the matter for hearing on October 14 as Additional Solicitor General S V Raju was not available.

Senior advocate Kapil Sibal, appearing for Boipally, submitted that the petitioner was arrested in October 2022 and referred to AAP leader Manish Sisodia case while seeking bail for him. During the brief hearing, advocate Zohab Hossain, appearing for the ED, told the court that Boipally has been out on interim bail owing to the condition of his wife, who is suffering from various ailments, since March 6 and requested the court to hear the matter in the presence of ASG. The apex court then adjourned the matter as the

ASG was not available while extending the interim relief.

On March 20, the top court noted that the businessman has been in custody for 18 months and directed his release on interim bail for five weeks. Since then, Boipally's interim bail has been extended from time to time by the apex court.

While granting interim bail, the top court had asked Boipally to surrender his passport and directed him to not leave the National Capital Region (NCR) except for a visit to Hyderabad. The businessman has challenged the case July 3, 2023, order of the Delhi High Court that dismissed his petition questioning the legality of his arrest in 2022. The businessman had contested his arrest before the high court on the grounds of non-compliance with section 19 of the Prevention of Money Laundering (PMLA) which deals with the procedure for arrests.

## 54 Crore GST Refund Scam exposed by Delhi's Anti-Corruption Branch

NEW DELHI [INDIA] : In a massive crackdown, the Anti-Corruption Branch (ACB) of Delhi has uncovered a scam involving fraudulent GST refunds within the Trade & Taxes department of the Delhi Government and arrested a Goods and Service tax officer along with six associates.

Seven people were arrested for allegedly running the racket of fake invoices and getting GST refunds from the department. The seven arrested persons include a GST officer, three advocates, two transporters, and a fake firm proprietor, informed ACB.

According to ACB, They created 96 fake firms, which were cunningly used to siphon off taxpayer money by claiming fraudulent GST refunds.

Shockingly, refunds worth rupees 35.51 crore were approved between 2021 and 2022. In the first year, only refunds worth rupees 7 lakh were approved but later the remaining were approved.

The GSTO, identified as Babita Sharma, played a pivotal role in this conspiracy. After being transferred to Ward No. 22 in July 2021, Sharma, in a highly suspicious move, swiftly approved the migration of 53 firms to her ward. These firms, which were later found to be non-existent during a physical verification by GST officials, were mere paper entities, set up solely to claim bogus refunds. Within just 2-3 days of filing refund applications, these

refunds were sanctioned without the mandatory verification of Input Tax Credit (ITC), a crucial process to identify fraudulent claims, informed ACB.

The fake firms, which supposedly conducted business worth Rs718 crores, were found to be engaged in nothing more than a paper trail of deceit. Some firms even claimed to export medicines and medical items, but a closer inspection revealed that these transactions were built on forged purchase bills. It was found that the same group of offenders operated 23 out of these 96 fake firms. Using common email IDs and mobile numbers

## Feel happy that Atishi further strengthened Delhi's education system: Manish Sisodia

NEW DELHI [INDIA] : Former Delhi Deputy Chief Minister Manish Sisodia on Tuesday appreciated his party colleague and Delhi Education Minister Atishi for not letting the education revolution stop in Delhi and praised her for taking steps to further strengthen it.

The Aam Aadmi party leaders visited Rajkiya Sarvodaya BAL Vidyalaya in West Vinod Nagar in the city and interacted with students.

Students also tied Rakhis to Sisodia and Atishi.

"In the last 17 months, I was missing my visits to schools, and meeting children. I believe that children are a form of God. Today, I came here with Atishi. She did not let the conspirators stop the education revolution and I am very happy that she has even further strengthened the education system of Delhi," Sisodia, who was the former

Education Minister, said while interacting with the reporters.

"I came to know that 20 new schools have been started. One new sports school has been started. Such initiatives have never been taken before. During my tenure in jail, I used to pray that the education revolution must not stop," said Sisodia, who was recently released on bail after 17 months in connection with the Delhi excise policy scam.

Earlier on Friday, the Supreme Court granted bail to Manish Sisodia in the excise policy irregularities cases. The order has been delivered by a bench of justices B R Gavai and K V Viswanathan. The court also imposed various conditions including surrendering the passport and not influencing witnesses. On June 4, the top court also gave him the liberty to revive his prayer afresh after filing the final charge sheet.

## Fresh plea in SC following recent Hindenburg issue

NEW DELHI [INDIA] : New Delhi [India], August 13 (ANI): A fresh plea has been filed in the Supreme Court following the recent Hindenburg issue as the petitioner complained of the Supreme Court Registrar's alleged refusal to register the petition and urged the top court to direct the registry to register his miscellaneous application seeking compliance with the earlier top court's order.

The fresh plea stated that due to the recent Hindenburg controversy, it becomes incumbent for SEBI to conclude the pending investigations and

declare the conclusion of the investigations.

Advocate Vishal Tiwari has moved the fresh plea urging to allow his appeal against the lodgement order dated August 5, 2024, of the Registrar and to direct the registry to register the miscellaneous application.

"Allow the appeal of the petitioner against the lodgement order dated August 5, 2024, of the Registrar (Judicial listing) Supreme Court of India and direct the Registry to register the Miscellaneous Application and list before the Supreme Court for appropriate orders," the petitioner urged.
